APPROXIMATELY 140,000 MEALS WERE PROVIDED TO RESIDENTS AS WELL AS NON-RESIDENTS IN NEED OF NUTRITIONAL MEALS. 905 CLOTHING VOUCHERS WERE PROVIDED TO THOSE IN NEED. WHEN THESE MOST BASIC NEEDS ARE MET, INDIVIDUALS AND FAMILIES ARE ABLE TO FOCUS ON LEARNING LIFE SKILLS NECESSARY TO ACCESS AND MAINTAIN PERMANENT HOUSING.
